

## **Information clause**

*\*Information clause in accordance with art. 13 sec. 1-2 GDPR:*

- 1) *The administrator of your personal data is the Pomeranian Science and Technology Park Gdynia (hereinafter "Administrator"), the Budget Unit of the Gdynia City Commune, al. Zwycięstwa 96/98, 81-451 Gdynia, NIP 586 213 83 02, e-mail: [iod@ppnt.pl](mailto:iod@ppnt.pl); phone: 58 880 81 50.*
- 2) *In matters related to your data, please contact the Data Protection Officer, tel. 58 880 81 50, e-mail: [biuro@ppnt.pl](mailto:biuro@ppnt.pl).*
- 3) *Your personal data will be processed for the purpose of:*
  - *keeping your account via the website*
  - *[www.gdyniadesignday.eu](http://www.gdyniadesignday.eu) of the Administrator (Article 6 (1) (a) of the GDPR);*
  - *in order to sign up for events / conferences / training (Article 6 (1) (a) of the GDPR);*
  - *performing the obligations incumbent on the Administrator (Article 6 (1) (b, c, e) of the GDPR);*
  - *investigation / defense of claims, dispute resolution (Article 6 (1) (b), (c) of the GDPR);*
  - *sending the Newsletter and image processing - if you have given your consent (Article 6 (1) (a) of the GDPR).*
- 4) *your personal data will be processed in principle:*
  - *for the period of using the account;*
  - *for the duration of the Administrator's promotional, advertising or statutory activities;*
  - *after the completion of the above-mentioned actions, the data will be stored for the purpose of fulfilling the obligations provided for by law (including archival, pursuing claims or defending one's rights);*
  - *until an objection is raised or consent is withdrawn; after withdrawal of consent or objection, personal data may be stored for the purpose of demonstrating the correctness of compliance with the legal obligations incumbent on the Administrator and related claims (limitation periods for claims counted from the withdrawal of consent or the submission of objection).*
- 5) *The recipients of your personal data may be authorized persons, public authorities, entities / institutions specified by law or persons (including in the field of public information), entities cooperating with the Administrator on the basis of concluded contracts and agreements in the performance of activities related to the business the statutory regulations of the Administrator (including entities processing entrusted data and entities providing electronic payment services or via payment cards).*
- 6) *Providing your personal data is voluntary, but if you do not do it, it will not be possible to achieve the purposes for which the data was collected, e.g. setting up an account / subscription to an event / Newsletter / image processing.*
- 7) *Your personal data will not be transferred outside the European Economic Area or to an international organization.*
- 8) *The administrator does not make decisions in an automated manner, including the form of profiling within the meaning of art. 22 sec. 1 and 4 GDPR.*
- 9) *Under the terms of the provisions on data protection, you have the right to access your data, rectify it, delete and delete your account, limit processing, transfer data, withdraw consent (without affecting the processing before the withdrawal deadline) and object to processing. The right to object to data processing does not apply if: the processing of personal data takes place on the basis of consent, data processing is necessary to perform the contract to which you are a party, processing is necessary for the Administrator to fulfill a legal obligation.
